ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Sewerage System Improvements, October 2021** will be received, by **CITY OF DANIELSVILLE**, at City Hall, **10 Government Circle, Danielsville, Georgia 30633**, until **2:00 p.m.** local time on **September 28, 2023**, at which time the Bids received will be publicly opened and read. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of ninety (90) days. The Project consists of construction of:

Division I: Installation of approximately 25,500 linear feet of 8" gravity sanitary sewer, and approximately 8,000 linear feet of 6" force main complete with all appurtenances.

Division II: Installation of two sewage pump stations including precast wet wells, pumps, electrical, piping, site work and all appurtenances as well as replacement of pumps, piping control panel in an existing pump station and the demolition of one existing pump station.

Time of construction is 450 consecutive calendar days for substantial completion and 480 consecutive calendar days for final completion.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Proposals for the complete work in one ~~or more~~ general contracts shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

All Bidders must have a State of Georgia Utility Contractors License and must employ a state "Utility Manager" certificate holder who will have oversight of all the work.

Bidding Documents also may be examined at the office of the **CITY OF DANIELSVILLE, 10 GOVERNMENT CIRCLE, DANIELSVILLE, GEORGIA 30633**; Atlanta Builders Exchange in Atlanta, Georgia and the offices of the Engineer, Turnipseed Engineers, in Atlanta and Augusta on Mondays through Fridays between the hours of 8:00 a.m. to 5:00 p.m.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of **\$300.00** for drawings and specifications. Additional reduced sized drawings are available for **\$150.00** Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 30 days after receipt of Bids will receive a one-half (½) refund. Checks for Bidding Documents shall be payable to "Turnipseed Engineers." Upon request and

receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Upon receipt of all documents in undamaged condition within thirty (30) days after the date of opening of bids, one-half of the deposit will be refunded. The difference between the deposit and the amount refunded represents the cost of reproduction. No refund will be made for documents received after thirty (30) days or in damaged condition.

A pre-bid conference will not be held.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Bidders shall submit proof of qualifications to perform the Work as described in the Instructions to Bidders.

The Owner reserves the right to reject any or all bids and to waive informalities.

This is a Section 3 Covered Project under the HUD Act of 1968 and Section 3 Residents and Business Concerns are encouraged to apply. The City of Danielsville is committed to providing all persons with equal access to its services, programs, activities, education, and employment regardless of race, color, national origin, religion, sex, familial status, disability or age.

Section 746 of Title VII of the Consolidated Appropriations Act of 2017 (Division A – Agriculture, Rural Development, Food and Drug Administration and Related Agencies Appropriations Act, 2017) and subsequent statutes mandating domestic preference applies an American Iron and steel requirement to this project. All listed iron and steel products used in this project must be produced in the United States. The term "iron and steel products" means the following products made primarily of iron and steel" lined or unlined pipes and fittings, manhole covers and other municipal castings, hydrants, tanks, flanges, pipe clamps and restraints, valves, structural steel, reinforced precast concrete, and construction materials. The deminimis and minor components waiver apply to this contract.
