Sealed proposals will be received by the City of Warrenton, Georgia at City Hall, 29 Edward D. Ricketson Jr. St., Warrenton, GA 30828 until 3:30 P.M. local time, Tuesday, September, 19, 2023 at which time and place they will be publicly opened and read. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of ninety (90) days.

All Bidders must have a State of Georgia Utility Contractor License and must employ a state “Utility Manager” certificate holder who will have oversight of all the work.

The work to be done consists of furnishing all materials, equipment and labor for the construction of:

Approximately 240 tons of asphalt paving, 100 linear feet 18-inch storm pipe, 585 linear feet 24-inch storm pipe, grading, demolition, road widening, and all appurtenances associated with project construction.

Time allotted for construction is 180 consecutive calendar days for final completion.

Proposals for the complete work in one general contract shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

This is a Section 3 Covered Project under the HUD Act of 1968 and Section 3 Residents and Business Concerns are encouraged to apply. All proposals shall be accompanied by a Bid Bond drawn in favor of the City of Warrenton, Georgia in the amount of at least 10% of the lump sum bid for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for the City of Warrenton, Georgia. Each bond shall be equal to 100% of the contract amount. The Bid Bond shall be forfeited to the City of Warrenton, Georgia as liquidated damages if the Bidder fails to execute the contract and provide Performance and Payment Bonds within 10 days after being notified that he has been awarded the contract.

Drawings and Specifications are open to public inspection at the office of the City of Warrenton, Georgia and at the offices of Turnipseed Engineers in Augusta and Atlanta, Georgia.
